I realize that if my pet tries to bite a staff member or another dog, he/she will not be let outside for the remainder of his/her stay. I also realize that even though supervised, occasionally dogs get injured and I will be responsible for any veterinary bills incurred. I will also be responsible for any medical treatment needed if my pet ingests or gets injured by any material or objects from items left by me for my pet to have in his/her kennel.

This is a Contract between Berg Bros Setters, LLC (herein after called "Kennel" & "BBS") and the pet owner whose signature appears below (herein after called "Owner").

- 1.) Owner agrees to pay the rate for boarding in effect on the date pet is checked into the kennel.
- 2.) Owner further agrees to pay all costs and charges for special services requested and all veterinary costs for the pet during the said pet is in the care of the kennel.
- 3.) By signing this Contract and leaving his/her pet with kennel, Owner certifies to the accuracy of all information given about said pet.
- 4.) Kennel shall exercise reasonable care for the pet delivered by the Owner to kennel for boarding. It is expressly agreed by Owner and Kennel then Kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per animal boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the Kennel.
- 5.) Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
- 6.) Owner specifically represents to Kennel that the pet has not been exposed to rabies or distemper within a thirty day period prior to boarding.
- 7.) All Charges incurred by Owner shall be payable upon pick-up of pet. The kennel shall have and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding pet at the kennel. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the Kennel may exercise its lien rights upon ten days written notice given by Kennel to Owner by certified mail to address shown on contract.
- 8.) If pet becomes ill or if the state of the animal's health otherwise requires professional attention, the Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner. This includes diarrhea, vomiting, and coughing as well as any other illness. If pet may have a contagious disease or condition, diagnostic testing will be enacted at Owner's cost to prevent spread. Communication with Owner will be attempted.

Assumption of Risks

To make your pet's stay with us safe, enjoyable, and efficient, and to meet the requirements of the State of Minnesota, we have compiled a list of requirements for pets staying in our boarding facility. We ask that you please print this form, sign at the bottom and bring it in with you when you bring your pet in to be boarded.

1. To conform to the rules set up by the State of Minnesota to prevent proliferation of ants and mice, all food must be contained in a hard-sided container with a lid (Rubbermaid, Tupperware, coffee can, etc.).
2. To prevent the spread of disease while your pet is in our care, dogs must be current on rabies (both one year and three year vaccinations are acceptable), DA2PPV (annually or a distemper and parvo titer test will suffice) bordetella is required (6-months), Topical Flea & Tick applications and Canine influenza is recommended. All dogs must have copy of their vaccination records for us to view or permanently keep.
3. One toy will be permitted per dog. To prevent objects from getting stuck in the drainage system and easily cleaned, at least part of each dog toy must be larger than a tennis ball and made of a non-permeable material. Berg Bros Setters will not be held responsible for lost or damaged items.
4. To avoid confusion at check-out time, no bowls, brushes, or leashes will be accepted.
5. Bedding material is not recommended. We provide Kuranda Orthopedic beds for each dog. These beds enable us to offer a clean sanitized environment and comfortable sleeping bed for your pet.
6. To prevent unwanted matting, please provide notice to us if your dog is in heat or will be coming into heat while being boarded with us. BBS will provide private exercise time for your pet if they are in heat or will be coming into heat.
7. BBS will administer medications per your request to your pet. All meds are to be clearly marked with Pet's name.
8. Pet drop off is between 8:00 a.m. and 5:30 p.m., 7-days a week. However, we are available for arranging earlier or later times to meet your schedule.

As a pet owner leaving my pet at Berg Bros Setters Kennel, I understand that there are certain risks of injury or illness that are out of the control of the staff of BBS. Pets, by their very nature, are often times nervous, hyper-excitable, and don't always use good judgment. Hence they sometimes injure themselves while playing with other pets or over-reacting to being enclosed. I will not hold BBS responsible for injuries attained while in the care of BBS.

Pets also, by their very nature, are not as concerned with cleanliness as humans. For example, they defecate and urinate on the ground. Although the staff of BBS picks up waste as quickly as possible, sometimes pets race over to sniff it and sometimes touch their nose to and (rarely) consume it. They also lick each-others mouths and anal areas and chew on toys that other pets have been chewing on.

I understand that some diseases are airborne and do not require direct contact with other pets and that infectious pets are often not obviously infectious. I understand that my pet is in a social situation much like a human day care and that infectious problems are impossible to eliminate.

I will not hold BBS responsible for any infectious disease my pet might pick up while in the care of BBS.

I will not hold BBS responsible for any problems associated with anything ingested while in the care of BBS.

I am the owner of the pet(s), or agent for the owner of the pet(s) being left in the care of BBS and I agree with the statements above.

This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Kennel
